M/S Todd Christensen/Amy Peterson to approve the minutes of the August 1, 2022 meeting as presented. Motion passed unanimously.

Action items were reviewed. Those remaining were:

Approve Agenda

Planning & Zoning

-Mike presented the updated fee resolution.

M/S Dave Beckstrom/Amy Peterson to approve Resolution 22-05 publishing summary of updated fee schedule. Motion passed unanimously.

M/S Dave Beckstrom/Todd Christensen to approve Ordinance 22-03 containing updated fee schedule. Motion passed unanimously.

There was one location omitted from the Flood plain ordinance and it has been added.

M/S Todd Christensen/Dave Beckstrom to approve Ordinance 22-04 adding one location to the flood plain. Motion passed unanimously.

Zoning violations

-Over 200 tires on Shanandoah St

-Cash for cars, neighbors are complaining as there are more and more cars.

-The issue of people living in RV's all year will be discussed at P&Z this month.

-The issues with John Straight are getting worse. A discussion was held about possibly obtaining a search warrant.

-Mike has completed the municipal fee report for 2020 which was made difficult due to no totals from Andy.

-Stephanie Vanderbijl has a roof leak issue and is blaming the township citing faulty inspections. The board will not be getting involved in the issue. -The board received an update from Jason Ross with pictures of a berm and improvements made. The area has been seeded and grass is growing to cut down on dust.

-Mike again brought up the issue of electronic storage. Dave Beckstrom will check out the potential system that has been suggested.

-The issue of real time satellite was discussed. It is very expensive. There was also a discussion about the township purchasing a town. Several supervisors were against this idea. Mike will see what the county uses, and the discussion was tabled.

-The open P&Z position was addressed and AJ Ondrey was appointed.

Fire

Parks

Clerk's Report

Treasurer's Report

M/S Amy Peterson/Dave Beckstrom to approve the Treasurer's Report, Claims List for Approval, and Net Pay Account Distribution Report & IRS (checks 7750-7778 plus IRS totaling 23,089.28). Motion passed unanimously.

-Marlys gave us a new sheet updating ARPA funds.

M/S Todd Christensen/Dave Beckstrom to move ARPA that we have used from the Road and Bridge and Fire accounts to a separate fund so that we know what was ARPA money. Motion passed unanimously. We will use capital projects account.

-The treasurer and the clerk are in balance.

-Marlys gave a budget report.

-Payroll reminder for third quarter.

The air compressor in the shed is no longer working. M/S Amy Peterson/Dave Beckstrom to spend up to 800.00 on a new air compressor. Motion passed unanimously. Curt will purchase one.

M/S Todd Christensen/Amy Peterson to pay Jason Ross 300.00 to take down the ridge at the back of the park property to

discourage people from digging it all up with four wheelers. Motion passed unanimously.

M/S Amy Peterson/Todd Christensen to adjourn the meeting at 8:46 PM. Motion passed unanimously.
