Planning & Zoning

M/S Todd Christensen/Chris Olson to approve Resolution 2020-15 approving the IUP for Jeff Alfveby. Motion passed unanimously. Conditions for the approval were read by Mike.

- -Peter Tiede is looking into the issue of Fay Olson, the three separate lots with one PID.
- Mike discussed some zoning violations 900 267th Ave NW running a business out of a home. A citation was issued but we have received no response.
- -Also, the sign on highway 65 for the dance studio/rental business has to be taken down.
- -There will be no P&Z meeting for December.
- -Mike is working with Lisa McCormack as our septic program is out of compliance.
- -A discussion was held about using the sign for community notices. Mike will put together parameters for using it. Mainly it should be kept to nonprofits, and programs serving the community.
- -Mike Warring gave a county update.
- -Lyle Reynolds gave a county update.
- -A discussion was held about filling the seat that will be vacant on P&Z after the Board of Reorganization is held. Jason Ross was proposed as a possible candidate by Todd Christensen.
- -The septic system at the town hall needs repair.

-Jerome contacted Dave Henderson regarding the solar farm not following up with the tree planting which is a condition of the CUP. Dave will follow up and look into the situation.
