




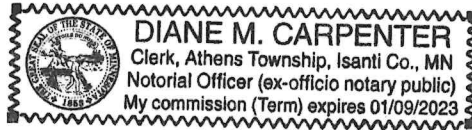
THE TOWN BOARD OF ATHENS ORDAINS:

Article X. Flood Plain Overlay District.

Section 20-172 General Provisions



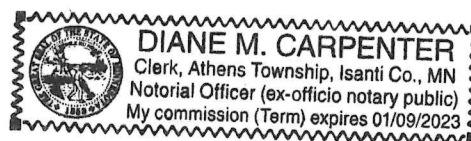
